The Journal of Amish and Plain Anabaptist Studies welcomes manuscripts, both theoretical and empirical, about plain Anabaptist groups, including Amish, Apostolic Christian, Brethren, Bruderhof, Hutterite, Russian Mennonite, Swiss Mennonite, and related movements. Under normal circumstances, the manuscript should be no more than 10,000 words, including tables, figures, endnotes, and references. Abstracts may be up to 200 words. Citation and referencing style is similar to the *American Journal of Sociology* (<http://www.jstor.org/page/journal/amerjsoci/instruct.html>).
