The regular meeting of the University Council was called to order by the Chairperson, Senior Vice President and Provost, Dr. Frank Marini, at 3 p.m. on Thursday, April 3, 1985, in Leigh Hall 307.

Fifty-three of the seventy-seven members of Council (including four ex officio for 1985-86) were present. Those absent with notice were Jean Blosser, Robert Dubick, Charles Dye, Judith Fitzgerald, William Fleming, Gerard Knieter, Walter Lehrman, Warner Mendenhall, William Muse, William Rogers, John Serafini, John Watt, Deborah Weber, and John Works. Absent were Helen Cleminshaw, Russell Davis, Robert Eley, Claibourne Griffin, Valerie Hill, Julia Hudson, Jacqueline Johnson-Chambers, Ginger Lynch, Paul Merrix, and Ralph Turek.

The Secretary of Council noted the following corrections to the minutes of the regular meeting of the University Council of March 6, 1985:

- Page 2: Dean Knieter was recorded as "absent." This should be changed to indicate "absent with notice."
- Page 3: Under President Muse's remarks, in the first entry regarding the Capital Improvements Bill, the second "by" should be corrected to read "but" so that the phrase reads "... an increase from the \$47 million recommended by the Board of Regents but less than the \$13.8 million requested."

In the third entry under the Capital Improvements Bill, the \$10 million should be changed to \$2 million (for the expansion of Auburn Science and Engineering Center).

Page 7: At the beginning of the second paragraph, <u>Dr.</u> Elton Glaser should be changed to <u>Mr.</u> Elton Glaser.

Mr. James Inman also suggested the following corrections on Page 9:

In the second paragraph, third and fourth sentences, Inman suggested the phrase "... one major idea associated with the proposal. The first one was the fact ... " be deleted and the word "instead" be inserted in its place to combine the two sentences to read "He pointed out, instead, that when new administration ... "

In the third paragraph, the word of should be changed to or.

Following approval of the minutes as corrected, Dr. Marini made an announcement in lieu of remarks of the President. Referring to a memorandum dealing with the subject of faculty and staff recognition receptions, sent out by Dr. Muse on March 18 to deans, vice presidents, and department heads, the Provost indicated that the deadline for nomination for faculty and staff recognition awards (which was Tuesday of this week) could be changed to Thursday, April 10. He encouraged those present to pass the information on to other colleagues so that participation would increase.

Dr Marini then turned to special announcements on the agenda, the approval of candidates for the 1985 mid-year commencement and January 1986 degree conferral. Mr. Robert Weyrick moved approval of the two lists and the motion was seconded. The motion carried unanimously.

Continuing with the reports of the standing committees, Dr. C. Frank Griffin reported that the Procedural Committee met on March 21 to set the agenda for the Council meeting. In addition, the committee honored the request of Professor Don Gerlach to speak at this Council meeting. At the urging of committee members, the Provost agreed to send the report of the Ad Hoc Committee on General Studies to the Academic Policies, Curriculum and Calendar Committee.

Speaking for the Academic Policies, Curriculum and Calendar Committee, Mr. Robert Weyrick recommended to Council the approval of 19 curricular proposals, indicating that a list of these proposals had been previously circulated to Council members. The proposals which he recommended for approval are AS-86-30, CT-86-08 and 09, ED-86-03, EN-86-05 and 07, FA-86-03, 05, 10, 11, 17, 18, 24, 28, and 29, NU-86-02, WC-86-02 and 03, and IN-86-02. On Mr. Weyrick's motion, Council passed these curricular changes. The descriptions for these curricular changes are in the appendix of this <u>Chronicle</u>. Mr. Weyrick also announced that the committee disapproved curricular proposal IN-86-01.

Dr. Walter Arms reported for the Athletics Committee. He announced that the committee met on March 18 and that they offered congratulations to the basketball team on its fine finish in the NCAA tournament. The committee also reminded Council that The University of Akron will be hosting the women's softball tournament on May 15-18. Currently the Akron women's team is ranked second in the nation. Arms continued by saying that spring football practice has started and the football team has moved to the stadium which allows more locker space than that available at Buchtel field. The application to the Mid-American Conference which had previously been submitted has been postponed until November. Therefore, Arms explained, the Athletics Committee has supported the application which has been made to the Metro Conference. That conference includes Cincinnati, Louisville, Memphis State, Southern Mississippi, Florida State, South Carolina, and Virginia Tech. This application will be on Metro's agenda this spring. Because Metro does not play football as a conference, the University may have to go independent in football, or a new conference may be established from previously independent teams. The University has informed Ohio Valley Conference officials of its intent to leave the conference after the 1986-87 year. Concluding, Dr. Arms acknowledged that rumors have been running rampant lately regarding athletics, and he urged Council members to contact any committee member for clarification.

Dr. David Timmerman reported for the Campus Facilities Planning Committee. He indicated that the committee met on April 1. The committee continued discussion of the results of the recently completed faculty survey on classroom conditions. Routine maintenance problems which were identified were turned over to appropriate departments for correction. Most of the meeting was spent discussing existing and possible future criteria for minimum classroom standards with Randy Richardson, the acting University Architect. Based on the results of the classroom condition surveys conducted last year and again this year, considerable improvement has taken place with respect to routine maintenance, and further improvements are anticipated. However, unsatisfactory classroom conditions identified across much of the campus will prohibit simple, inexpensive solutions. These include such items as the heating, ventilation and air conditioning system, space utilization and overcrowded classrooms, acoustic and noise related problems, and rooms not designed or equipped for efficient audio/visual usage. Concluding, Dr. Timmerman indicated that since education is one of the major functions of a university, and since education can only be carried out effectively if the learning environment and facilities are adequate, the Campus Facilities Planning Committee strongly recommends that this vital need be given proper priority and consideration in future allocation of University resources.

Reporting for the Faculty Rights and Responsibilities Committee, Dr. Dale Jackson announced that the committee met on April I to continue consideration about items relating to faculty appointments and tenure. The committee decided to solicit comments from faculty and administrators and has scheduled open hearings. The details of those hearings will be circulated to all faculty members. The committee intends to make recommendations to Council at its May meeting.

There was no report from the Faculty Well-Being Committee, but Dr. June Burton did announce that the committee expects the first report from the health consultants around the middle of April.

Dr. John Gwinn reported that the Library and Learning Resources Committee met on March 11 to review the current budget allocation for library materials. The committee expressed concern that the current amounts and the projected increases are scarcely sufficient to keep up with increased costs or to expand or significantly strengthen the library's holdings. As a basis of comparison, one subcommittee is trying to learn the percent of the total budget of similar institutions that is designated for library materials. Different accounting systems has made this much more difficult, but Gwinn reported that work continues. Last year the library conducted a comprehensive review to assess faculty use and faculty ratings of library services and resources. The study revealed that in spite of the diversity of the services and resources, most faculty seem to regard the Library only in a traditional way--books, journals, & reference materials. Many faculty never make use of information from documents, microforms, archives, or Computer Based Education. Similarly, relatively little use is made of videotapes and other audio/visual materials. The study also revealed many negative comments about the quality of the collection, but overall it was rated "adequate to good." One service that received much criticism dealt with the ordering and delivery of audio/visual films and equipment. Many of the issues raised by this survey were addressed in the ULLR five-year plan, which the committee reviewed. Gwinn also reported that the subcommittee dealing with the scope, size and number of departmental libraries has nearly completed its data collection and should report at the May meeting. The subcommittee on Computer Software Policies continues to develop recommendations regarding the library's role in the purchase, cataloging, use, and storage of computer software. Lastly, the faculty borrowing privileges that were circulated earlier have been slightly revised to include sending a reminder to faculty members two weeks prior to the due date on 150-day loans.

The Reference, Research and Student Affairs committees had no reports. The Akron Representative on Faculty Advisory Committee to the Chancellor of the Ohio Board of Regents had no report either.

Moving to old business, Mr. James Inman began discussion on the proposed amendments to the bylaws of University Council by distributing some revisions to the proposals. He then moved that what was proposed at the March meeting be divided by article so that consideration can be made item-by-item, with the exception of Article III and Article IV, which Inman suggested should be considered as one unit, since they both involve the composition of Council. Mr. Elton Glaser seconded the motion, and it carried unanimously.

Proceeding with discussion on the proposed amendments to Article II, Inman moved to adopt the following revised language which was distributed to replace the proposed language for amending the first paragraph:

> The Council shall review and offer recommendations concerning proposals for the creation, abolition, or rearrangement of colleges, departments, or divisions of instruction, proposals from university-wide committees and such other matters as may be referred to Council by the President of the University. Such proposals shall be forwarded to the Procedural Committee for inclusion on the agenda of Council meetings.

University-wide committees which are created by Council shall report to Council unless otherwise indicated by Council; other university-wide committees shall report to the parties or body creating them and shall file an information copy of such report with the Procedural Committee, except that the President's Advisory Committee, the Provost Advisory Committee, Grievance Committee, committees dealing with confidential personnel matters, and other committees where the President of the University determines confidentiality is required shall not file such information reports with Council. The Procedural Committee will include the report on the agenda of Council meetings.

This revised language, explained Inman, resulted from the discussion at the previous meeting. Dr. C. Frank Griffin seconded the motion. Dr. Katherine Hinckley requested clarification on whether or not the new wording meant that individual members of the Council would be permitted to offer proposals on such matters, as addressed in the proposed paragraph. Inman indicated that the new language did not preclude members of Council from offering proposals, but that it was likely that Council would reject such a proposal which did not go through usual channels of the University. Hearing no further discussion, the motion to substitute the new language into the proposed amendment to Article II was was put to a vote and carried with one opposing vote.

Following adoption of the new language, Inman moved to adopt the entire proposal for Article II. The motion was seconded. Dr. Dale Jackson requested clarification on where the proposed amendment would be added. Inman replied that the new language would be added to the existing first paragraph, in addition to creating a new paragraph on University-wide committees, and the existing last paragraph would be replaced by the proposed new language as indicated. Dean Hill asked if it was in order to vote to delete the last paragraph and add the new language since the proposal was to be divided by article. Inman indicated that the entire new language had just been adopted, and now all of it should be inserted in Article II. The motion was then voted on and carried. Article II of the Bylaws of the University Council now appear as follows:

POWER AND DUTIES

The University Council of the University Faculty is the legislative body thereof, and the Board empowers it to formulate suitable rules, requirements and procedures for the admission, government, management and control of the students, courses of study, granting of degrees and certificates, and other internal affairs of the institution necessary to meet the objectives of the University in accordance with the established policies of the Board.

(Bylaws and Regulations of the Board of Directors, June 21, 1967)*

The Council shall review and offer recommendations concerning proposals for the creation, abolition, or rearrangement of colleges, departments, or divisions of instruction, proposals from university-wide committees and such other matters as may be referred to Council by the President of the University. Such proposals shall be forwarded to the Procedural Committee for inclusion on the agenda of Council meetings.

University-wide committees which are created by Council shall report to Council unless otherwise indicated by Council; other university-wide committees shall report to the parties or body creating them and shall file an information copy of such report with the Procedural Committee, except that the President's Advisory Committee, the Provost Advisory Committee, Grievance Committee, committees dealing with confidential personnel matters, and other committees where the President of the University determines confidentiality is required shall not file such information reports with Council. The Procedural Committee will include the report on the agenda for Council meetings.

All legislation introduced in the University Council shall be designated as such and if passed shall be forwarded to the Board of Trustees through the President, with the exception that if the President deems it unnecessary to send certain legislation of Council to the Board, such legislaiton shall become effective 45 calendar days after the date of transmittal to the President.

Legislation sent to the Board of Trustees becomes effective 90 calendar days after receipt by the President unless the Board of Trustees disapproves, or notifies Council that it requires additional time. In the latter event it shall designate a date by which it shall finish its deliberations. Such postponed legislation becomes effective upon such designated date unless previously disapproved by the Board of Trustees.

The President of the University shall notify Council of the disposition of its legislation within 45 days of its passage indicating whether the legislation has been approved, referred to the Board of Trustees, or returned to Council for reconsideration or amendment.

Moving on to Article III, Inman moved that Council direct the Procedural Committee create an ad-hoc committee of University Council to study the issue addressed in Article III--Composition of Council. He cited extensive discussion at the last meeting and afterwards as the reason for referring the proposed amendment, and suggested the ad-hoc committee could concentrate on considering the size of Council and when new members should take office. He also indicated that he would make a similar motion on Article IV at the appropriate time. William Yoho seconded the motion. Dean Hill reminded the body that, since Inman's original motion to separate the articles for discussion excluded amendments III and IV, Inman's current motion should include both articles at once. Inman agreed and corrected his motion. Dr. Frank Griffin pointed out that if the amendment is referred to a committee for consideration, when a recommendation is brought back to Council, a different body would be receiving the recommendation, since membership changes in May. Tony Brown asked how long they would meet before making recommendations. Inman responded that he is not directing any time limitations. The Chairperson then put the motion to a vote, and it carried.

Turning attention to amendments to Article V, Inman again moved that the proposed changes be referred to the same ad-hoc committee for review. Brown seconded the motion. Glaser asked for the reasoning behind referring the proposal, pointing out that there was little opposing discussion at the last meeting. Inman indicated that since that meeting, the proposals have been circulated University-wide, and he has received several comments on them and has met with faculty to discuss their concerns. Because of these doubts, he said, he felt it would be better to have the issue studied. Glaser asked for some examples of concerns. After summarizing the content of Article V, chairmanship of the body, Inman explained that some people were concerned that if the Provost were removed as chairman, he may not continue to attend the meetings, as has seemed to happen with the President of the University, who used to chair the Council. In addition, it was expressed that if the Provost was removed from the chair, there might be less chance for lively debate; if he speaks first as a neutral member of the body, other members are less likely to express their views. By making him Chairman, people may feel more comfortable expressing their opinions. Also, having the Provost as the Chairperson creates prestige for the body in its recommendations to the President and ultimately the Board of Trustees.

Brown then expressed an opinion that it should be one of the duties of the Senior Vice President and Provost to preside as Chairman of the Council; and if people are inhibited by his role, they need to overcome that personal feeling. At this point, Dr. Marini emphasized the fact that the issues being discussed were constitutional issues and not simple legislation; therefore, he would be lenient with discussion. He also pointed out that the question on the floor was whether or not to refer the issue to the ad-hoc committee. Tim Elsass expressed concern over the composition of the ad-hoc committee--whether it would be representative of all aspects of University Council. Inman indicated that that would be taken into consideration by the Procedural Committee.

At this point, Professor Gerlach took the floor to speak against the motion to defer the issues. He said it seemed an unnecessary delay and that if the body was to be representative of the University, it should be free to choose whomever it wishes to serve as the chairman. He felt that the prestige of the body depends upon the character of all its members and not solely upon who serves as chair. He continued by saying that the Provost deserved to be heard, whether it be from the chair or the floor. Regarding a proposal to change the name of the presiding officer and arguments against the suggested title, Gerlach said that gender quibbling would be eliminated by use of the term "President" and there is little need for concern of confusing that title with the President of the University.

William Yoho then reiterated Marini's comment that the issues under discussion were constitutional matters and warrant additional consideration. The motion was then voted on and it carried.

Continuing with Article VI, Inman moved that the proposed amendments for Sections b, c, f, and g be referred to the same ad-hoc committee for additional review. Elsass seconded the motion. Inman explained that these sections pertain to the officers of Council and the composition of the Procedural Committee. The Chair then called for the vote and the motion carried.

Referring to the remaining proposed changes for that article, Inman moved for adoption of the the third paragraph, which deals with Section d. He explained that the change would provide for continuity on University Council standing committees. Glaser seconded. Dr. William Beyer pointed out that the proposed new committee, Academic Planning and Priorities, was included in that paragraph, but the provision for the creation had not yet been adopted. To include the new committee in this section would be to presume that Council will adopt the amendment. Inman concurred and agreed to remove the wording for the new committee until the issue was determined. At that time, if appropriate, the Academic Planning and Priorities Committee could be added to the paragraph in Article VI, Section d. Dr. Marini suggested changing the wording to include the committee now, and to add the clause "if such a committee is created in later discussion." Inman accepted the friendly amendment. Marini then called for a vote on the motion, and it carried unanimously. Article VI, Section d, now appears as follows:

> The Procedural Committee shall prepare the agenda for each meeting, specifying the particular items of business to be considered. It shall, in September, and after considering preferences of Council members, appoint all permanent and ad hoc Committees of Council with the exception of the Faculty Well-Being and the Faculty Rights and Responsibilities Committees and the University Council Committee of Department and Division Heads. This Committee of Department and Divison Heads shall consist exclusively of the heads of all academic departments and divisions, and shall elect its own officers and chairman. To provide some continuity of membership for each Committee, the Procedural Committee shall appoint Committee members so that, if possible, only one-third of the membership of any Committee is terminated each year and

members serve a three-year term. Besides the Procedural Committee, other permanent committees of Council are: Academic Policies, Curriculum and Calendar; Athletics; Campus Facilities Planning; Library and Learning Resources; Reference, Research; Student Affairs; Faculty Well-Being; Faculty Rights and Responsibilities; and Academic Planning and Priorities, <u>if such a committee is created</u>. (The underlined portion was subsequently deleted when the provision for the committee was adopted into the Addendum to the Bylaws.)

The Rights and Responsibilities Committee shall consist of one member from the tenured faculty of each College and Bierce Library, elected by its full-time faculty. Deans, and such decanal persons are ineligible to serve on the committee. Mmebers shall serve overlapping three-year terms so that one-third are elected each year. The Committee shall elect its own chairman who, if not a lready a member of Council, shall become an ex officio nonvoting member of Council. The Well-Being Committee shall consist of one member from the full-time faculty of each College and Bierce Library, elected by its full-time faculty. Deans, Associate Deans, Assistant Deans, the Director of University Library and Learning Resources and such decanal persons are ineligible to serve on the committee. Members shall serve overlapping three-year terms so that one-third are elected each year. The committee shall elect its own chairman who, if not already a member of council, shall become an ex officio nonvoting member of Council.

Regarding Article VII, Inman explained that most of the proposed changes were for miscellaneous items, and that the main entry provided for Council to meet in September, at which time the new members would commence their term. After this explanation, he moved that the entire proposal for that article be referred to the ad-hoc committee. After the motion was seconded, Glaser asked for the reason for referring the issue to the ad-hoc committee. Inman said he felt there was no immediacy on the issue. Glaser felt it should be settled before another year passes and September goes by without a meeting. Inman pointed out that the Board of Trustees would have to approve the change, and this would probably delay the change from being made effective until after September anyway. At this point, Marini volunteered a commitment to call the Council to order in September if the body so willed. Hearing no additional discussion, the Chair put the motion to a vote and it carried.

Turning to the addendum, Inman moved that three changes be made to the proposed language. The first change would be in the paragraph which establishes the Academic Planning and Priorities Committee; he suggested adding a semicolon after "reported to the Provost" and deleting the remainder of that sentence, then adding in its place, "an information copy of such shall be reported to University Council." Mr. John Miller seconded the motion. Hinckley asked why the "informational copy" phrase should be added. Inman explained that it would be more consistent with the language adopted in Article II. The motion was then voted on and carried.

Inman continued by moving a second change, which would be in Section c; he suggested adding the term "Pro Tempore" after "President." The motion was seconded and carried. The last change in wording which Inman proposed was to delete the last sentence in that same section, Section c. Inman explained that the committee could find their own way to report to Council. After the motion was seconded, Brown asked for clarification on the motion which had previous been passed. Inman explained that there already is a President Pro Tempore, and the motion that was just adopted simply included the existing title in the proposed change. The Chair then called for the vote and the motion carried.

Following adoption of all three changes, Inman moved adoption of the proposal for the Academic Planning and Priorities Committee to be added as a committee of Council. In addition, he included that if the motion were adopted, the provision for the committee should be inserted in other relevant sections of the bylaws (Article VI, Section d, paragraph 1, as previously identified; and Addendum, Procedural Committee, end of paragraph). Glaser seconded the motion.

Gerlach took the floor once again to express a feeling that if the Academic Planning and Priorities Committee were made a committee of Council but only for informational purposes, it really served no purpose as a Committee of Council.

Inman explained that it would have the responsibility to Council to inform. The Provost's Advisory Committee, which is comparable to the proposed committee, advises the Provost on various matters, including planning. But they do not report to Council. Therefore, most faculty members do not know the recommendations they have made. In addition, some people felt that the Provost's Advisory Committee should not be making priority decisions about academic affairs. The President therefore agreed on the formation of this new committee. Hinckley asked if the intention was that the proposed committee would make information reports only and that Council would not have the opportunity to indicate approval or disapproval of the committee's work. Inman explained that Council has the right to comment on any report it receives. Griffin pointed out that currently there is no provision for the existence of the Provost's Advisory Committee. Therefore, the Provost could choose to depend upon other sources for advice or to make decisions independently. By adopting the proposal, there would be a guarantee that such an advisory committee would exist. Beyer asked if the new committee would be involved with the curriculum process. Inman explained that the committee would be responsible for reviewing the plans presented by the academic units, setting priorities for these plans and advising the Provost regarding allocation of resources. Dean DeYoung expressed the idea that, even though most faculty on campus have not had any kind of feedback from the Provost's Advisory Committee, the reason may be that no strategic plan has been forwarded yet for review. She continued by questioning why no administrative input would be included in the make-up of the committee. Inman explained that the reasoning behind that decision was that the deans collectively review one another's plans and make recommendations to the Provost. He added that the wording for the provision of the committee was taken from that of the Faculty Well-Being Committee. Dr. Marini emphasized Inman's and Griffin's points that he does ask for advice from the faculty and deans, and that adoption of the proposal guarantees the existence. Marini then asked if there was objection to voting on the motion. Hearing none, he called for a vote on the motion, and it carried. The following is the adopted language which provides for the Academic Planning and Priorities Committee and should be added to the Addendum.

Academic Planning and Priorities Committee

In conjunction with the Provost, this Committee reviews the proposed plans of academic units and recommends priorities among such plans. Such recommendations shall be reported to the Provost; an information copy of such shall be reported to University Council.

The Committee shall consist of the following:

- a. One member from the full-time faculty from each of the degree-granting colleges, elected by its full-time faculty:
 - 1) Arts and Sciences
 - 2) Business Administration
 - 3) Community and Technical
 - 4) Education

- 5) Engineering
- 6) Fine and Applied Arts
- 7) Law
- 8) Nursing
- 9) Wayne General and Technical
- b. One member from Bierce Library, elected by its full-time faculty.
- c. President Pro Tempore of University Council.

Deans, Associate Deans, Assistant Deans, the Director of University Library and Learning Resources, and persons of similar decanal rank are ineligible to serve on the Committee. Members shall serve overlapping three-year terms so that during two years four are elected, while three are elected during the third year.

Marini then called attention to the fact that a proposal to amend the first sentence of the section on the Faculty Well-Being Committee had been skipped. Inman explained the proposed changed and then moved to refer the issue to the ad-hoc committee. The motion was seconded and carried.

That concluded discussion on the proposed amendments to the bylaws of University Council. Turning to additional old business, Marini informed the body that the item on the table from the Athletics Table would remain on the table until Council meets in May. Hearing no discussion for new business, the Chair called for a motion to adjourn. The motion was seconded and carried.
